NOTES CONCERNING THE APPLICATION

1. All parts of the Application Form must be completed, and copy of Birth Certificate provided, before the application can be considered by the Governors. The recommendation at the end of the Application Form should be signed by someone of appropriate standing, ie headmaster, clergy etc, outside the family of the applicant who is adequately familiar with the family circumstances and to whom the Governors may refer for further information if necessary.

2. Details of termly grants should include all contributions to fees made other than from parental income, ie scholarships or bursaries, grants from other charities, allowances from employers, donations from relatives etc.

3. A grant may be subject to reduction or discontinuance if, in the opinion of the Governors, the applicant's circumstances alter to the extent that a change is considered appropriate, or if funds are no longer sufficient.

4. If, in the opinion of the Governors, any person receiving a grant from the Foundation is guilty of serious misconduct, or fails to maintain a reasonable standard of industry and proficiency, or ceases to pursue the course for which the grant was made, the Governors may decide to discontinue the grant. In making their decision, the Governors may act on the report of the proper authorities of the institution at which the recipient may have been placed, or on such other evidence as the Governors think is sufficient. Under this provision and under the provisions of paragraph 2 the decision of the Governors shall be final in each case.

5. Annual grants are valid for one year only, but are renewable at the discretion of the Governors and usually without the need for further application.
